2020 Residential Visit to Kilve Court

Dear Parents

Following our very successful and enjoyable residential to Kilve Court this year, we shall once again be organising a similar trip for our Year 3 and 4 children in March 2020.

The centre offers many activities so we run the Year 3 and 4 visit on a 2-year rolling programme with many different activities and challenges. The children learn to live and work together as a supportive team.

This year the Year 3 and 4 children will be doing activities such as shelter building, the climbing wall, a stream walk, grass sledging and low ropes. We will also explore the wider environment and look for signs of Quantock wildlife on one of the many Quantock walks available, and undertake a beach study at Kilve beach. In the evenings there is an opportunity for playing social board games and taking a night walk listening and looking for Kilve's night life.

We have reserved the dates **Wednesday 4th March - Friday 6th March 2020**. There are a maximum of 60 places for this residential and the cost of this visit will not exceed £160.00, which includes coach fare to and from Kilve. As with all trips of this kind the Governing Body have adopted the County Charging Policy. To make this trip financially viable and to ensure it goes ahead, there will need to be a sufficient take up. If you are in receipt of Income Support, please contact the school for further details.

If you would like your child/children to take part in this visit, we will require a non-refundable deposit of £50.00 per child by 25th October 2019. The remaining payment can be paid in two instalments of £55 each, the first by 13th December 2019 and the second by 7th February 2020. All payments are to be made via ParentPay. This trip will be published for payment in September 2019.

Please complete the form attached confirming payment of **a non-refundable deposit of £50 per child** and return it to school by Friday 25th October 2019. The deposit secures your child's place. This year we are only securing places on receipt of the full £50 deposit.
