School Admission Appeals Timetable

1 March 2020 – 28 February 2021

Admission appeals are administered in accordance with the requirements of the 2012 School Admission Appeals Code issued by the Department for Education. Parents whose admission application is refused will have the legal right to appeal that decision. To lodge an appeal, complete and return the Appeal Form which can be downloaded from the School website or requested from the School Office.

On receipt of the completed Appeal Form, the Admission Authority will arrange for an appeal hearing to take place before an independent Appeal Panel. The timetable differs depending on when the appeal is lodged and whether it relates to an application to start at the school for the first time in September 2019 or to join the School during the academic year.

The following timetable applies:

Starting School in September 2020 – Admission decisions issued on 16 April 2020

Starting School in September 2020 – For appeals lodged after 17 May 2020

It may be possible for appeals lodged after 17 May 2020 to take place at the same time as those lodged before this deadline, providing there is sufficient time to make the appropriate arrangements. Otherwise, appeals lodged after 17 May 2020 will be heard within **30 school days** of receipt of the appeal form

Lodging an appeal relating to an In-Year admission application decision

An appeal may be lodged within **30 school days** of the admission decision being issued. An appeal hearing will be scheduled to take place within **30 school days** of receipt of the appeal form

| Additional information relevant to the appeal may be submitted to the clerk for distribution. Information submitted after this deadline will not be considered unless the chair of the appeal panel specifically agrees to this. | Up to two school days before the appeal hearing is to take place |
| The decision of the Appeal Panel will be notified to the appellant(s) in writing. | Posted out within five school days following the appeal hearing |
